When ordering online and the online vendor doesn't ship to your location, we provide a U.S. mailing address in Hawaii, USA for you to use. Once we receive your package(s), we will repack, consolidate or reinforce your packages, create your custom forms, pay the postage and forward to your P.O Box #.

MF service fee <sup>1</sup>starts at \$25 + USPS shipping rate for 1 package up to 40lbs. Additional packages in the same order start at \$6.25 (max 5) requiring CP 72 - Customs Declaration Form in the same order. See *<sup>2</sup>basic guideline* we use to estimate cost. We can consolidate orders to decrease package numbers going out.

### 2. PICK UP PACK MAIL SERVICE (PPM):

We pick up items you've sourced from any location on Oahu or order online for you, pack your item(s), and mail it directly to your P.O Box. The <sup>1</sup>cost for PPM service starts as low as \$35.00 + USPS shipping rate to pick up from one location. – Example pick up at Best Buy store, pack and ship.

### 3. PICK UP PACK FREIGHT (PPF)

We offer Air and Ocean Freight service for urgent or oversized items. Air Freight \*starts at \$275. Ocean Freight \*Starts at \$120. To get an estimate, please provide your package dimension and weight.

#### 4. PRODUCT/VENDOR SOURCING

Do you know what you need, but don't know where to get it? We can help with that too. Sourcing rates are \$35/hour if we find what you need, free if we don't.

#### 5. VENDOR OR BILL PAYMENT PROCESSING ON YOUR BEHALF

Deposit your funds to Suka Pacific account and we process payment to your vendors anywhere or hand cash to friends or family members on Oahu. This service is 3% on all transactions.

### 6. DIPLOMATIC/ DOCUMENT COURIER SERVICE

We offer courier service of diplomatic documents to the various consulates of the world located in Honolulu. This service is \$280 and includes receiving of documents/drop off/pick up/make payments & express mail postage for return.

Consulate processing fees are not included.



### 7. FREE RETURN SERVICE for Suka Pacific Clients

If you need to return an item to amazon regardless of how you received it, we will gladly help you return it without a service fee. Amazon requires a drop-off at UPS stores. We can help you with UPS drop-off at *no charge*. Just send us your item(s) with UPS return label and we will drop off for you within 24 hours of receiving.

#### <sup>3</sup>Why does Suka Pacific need a copy of my shopping invoice?

- To be able to fill out CP 72- Customs Declaration Form required to ship to your location.
- To aide as an itemized checklist for receiving and package consolidation.
- To avoid added service fees for product value research. Product value research rate is \$25.00/hour with a minimum charge of 15-minute increments or a fraction thereof.

#### Instructions and Tips on sending invoices:

• Send a copy of your shopping invoice(s) immediately after shopping to prevent delays in getting your package prepped for forwarding.

- We accept pdf copies of invoices or a list typed out providing item description, • quantity and value. List can be typed on the body of email, attached as pdf., spreadsheet or word document.
- Mobile apps are not good for downloading your full invoices on vendor sites, use • desktop or laptop.
- Avoid forwarding us your "order confirmations" if these don't show all products, • values and quantities.
- If your order list is long, avoid forwarding multiple invoices on separate emails or 5 • screen shots on messenger. We need to be able to print this list out. Kindly, collect all your data and consolidate to one email thread and one list so we can find everything easily and spend less time on consolidating your information more time consolidating your boxes.
